Because Prospect is in an exceptionally strong financial position, the Council's failure is inexcusable. On my first day as Mayor, I will work with the new Council to promptly adopt a budget that treats our police and other employees fairly.

I oppose the apartment complex that LDG proposes to build on the land across from the Kroger parking lot. My background as a trial lawyer will be an asset as we continue the fight to stop that project from going forward.
